PART I PROJECT DETAILS

1. Give a brief account of the project proposal (maximum of 50 words):

The aim of the project is to analyze religious beliefs and traditional notions in their relationship with contemporary global challenges, their mutual influence and the consequences of this symbiosis. The project will articulate and explore the most popular religious and traditional beliefs and ideas, their promoters ("actors"), their place and influence on vital aspects of individual and social life.

2. Summarise the length and nature of previous contact between the two groups:

The project develops and deepens the already existing research cooperation between Bulgarian and Estonian folklorists and ethnologists.

During previous periods The project's seminars (held in Bulgaria or Estonia) are regular.

- Regular joint seminars (1-2 per year);
- Field trips
- Lectures at the doctoral school
- Both sides participate at the academic conferences in Estonia and Bulgaria,
- Also the communication based on the joint projects within the Academic Exchange Programme – Bulgarian Academy with Estonia (Estonian Literary Museum), Latvia (Institute of Philosophy and Sociology, University of Latvia) and Lithuania (Lithuanian Institute of History), and the joint international conference series "Balkan and Baltic states in United Europe - History, Religion, and Culture)": held four times already (Sofia -2 times, Vilnius and Riga), 2022 will take place in Estonia.
- The results of the project (reports, articles, reviews, etc.) are published in authoritative national and international peer-reviewed publications, as well as in the international journal "The Yearbook of Balkan and Baltic Studies", created and published within the framework of international Academic Exchange Programme indexed in SCOPUS)
- 3. Outline the scientific aims of the joint project; include details of how the project objectives are to be met and the timescales involved:

The problem of the interactions between traditional ideas and beliefs, in the context of the modern perception of the opposition nature / culture, is especially relevant, It concerns both the conservation of nature and its diversity, on the one hand, and the challenges that threaten the human population and culture, on the other. These issues are becoming particularly important

against the background of climate change, declining species diversity, epidemic and pandemic phenomena, etc., facing new challenges for humanity. This issue has become increasingly relevant in recent years. Numerous scientific publications and forums in the academic world are dedicated to her

In Bulgaria and Estonia, religious ideas and traditional beliefs largely determine the national mentality and its manifestations in response to contemporary challenges, hey influence the attitude towards traditional / academic medicine. Based on "God's help" and "the power of herbs", etc., religious and traditional beliefs (the most striking examples are the so-called antivaccines and the failure of vaccination campaigns in the EU); to natural objects and characters facing the challenges of industrial and post-industrial culture, etc. They are often interpreted through the prism of traditional folklore (eg the belief in the migration of souls to trees - Estonia, under pressure from local communities determining the highways), religious concepts such as sin, punishment, apocalypse, etc.

The aim of the project is to analyze religious beliefs and traditional notions in their relationship with contemporary global challenges, their mutual influence and the consequences of this symbiosis. The project will articulate and explore the most popular religious and traditional beliefs and ideas, their promoters ("actors"), their place and influence on vital aspects of individual and social life.

The research will be based on the existing data, reflecting the religious and traditional notions, characteristic for the worldview of the modern Bulgarians and Estonians, highlighting specific, typological and universal features and mechanisms.

The pillars and dynamics of the development of religious and traditional beliefs, accepting modern challenges (which often turn them into "conspiracy theories" and the subsequent reactions) and the dialogue between them will be the subject of research.

The project, dedicated to one of the most current topics in the modern humanities and social sciences, will answer a number of questions related to the reactions of complex societies to modern realities. It will contribute to the development of the theory and methodology for understanding the modern post-industrial mentality not only in Bulgaria and Estonia, but also to modern science in general.

The project is based on field research conducted by the team, work with archival data (and the Institute of Ethnology and Folklore - BAS and the Estonian Literary Museum have rich archival funds on the project) and published materials on the project:

- virtual meetings 3 times, plus preparation of the special questionnaire
- field research in both countries;

- archiving, systematization is analysis of field materials;
- work in libraries and archives in both countries:
- consultations with colleagues;
- preparation of publications;
- presentation of the results at national and international forums.
