INTERNATIONAL COOPERATION AGREEMENT

This Agreement is made and entered into power on the date of the final signature hereto, by and between the Estonian Literary Museum, Tartu, Estonia (registered offices: Vanemuise 42, 51003 Tartu, Estonia, Reg nr 70003879; represented by the director Dr. Piret Voolaid) and

Institute of Ethnology, HUN-REN Research Centre for the Humanities, Budapest, Hungary (registered offices: 1097 Budapest, Tóth Kálmán utca 4, Hungary, tax code: HU15300629-2-43, represented by the director Dr. Balázs Balogh)

Article 1

The subject of this agreement is the scholarly cooperation in the fields of mutual interest and benefit of both institutions.

Article 2

The cooperation will include:

1. Implementation of mutual scholarly and research projects;
2. Implementation of ethnographic field research projects;
3. Participation in conferences organised by both sides;
4. Collaborative seminars, workshops and service programs;
5. Mutual publications and editions;
6. Exchange of publications and research staff;

Article 3

Each activity to be performed under this agreement will be undertaken pursuant to an addendum that will contain the specific terms and conditions governing the activity. These terms and conditions will be mutually agreed upon by the two institutions on a case-by-case basis.

Article 4

The costs of cooperation will be borne by both parties in accordance with their financial abilities, the possibility of each institution for seeking funds to support its involvement in the cooperative activities contemplated under this agreement or based on pre-agreed rules, and all such activities shall be dependent upon the budgetary appropriations of the parties.

Article 5

All activities developed hereunder will be in accordance with all applicable rules and regulations of the home and host institutions, and all applicable state and local laws, rules and regulations.

Article 6

The Estonian Literary Museum, Tartu, Estonia appoints Dr. Piret Voolaid, and the Institute of Ethnology, HUN-REN Research Centre for the Humanities, Budapest, Hungary appoints Dr. Katalin Vargha, to coordinate the overall development and implementation of this agreement.

Article 7

All modifications to this agreement must be in writing and signed by both parties.

Article 8

This agreement will remain in effect for a period of five (5) years with the possibility of its prolongation, unless one of the parties decides to terminate it. Either party may terminate the agreement with 90 days prior written notice to the other party, provided that such termination will not affect the completion of any activity underway at the time or any previously advertised activity in which commitments to each institution have been made.

The agreement is valid from the date of signature of both parties in four (4) copies, two for each institution.
